- Providing increased clarity on IP for graduate research,
- Ensuring that the policy is fit for purpose in light of increased entrepreneurial and start-up activity across the University, and
- Setting clear expectations regarding Indigenous Cultural and Intellectual Property.

University of Melbourne's Health Economics Short Courses in October

The University of Melbourne is hosting three upcoming Health Economics short courses, which have been designed to assist policymakers, clinicians, researchers, managers and others working in the health sector with an understanding of health economic issues, and how this can aid decision making.

Introduction to cost-effectiveness analysis in health (10th October, In-person)

An introductory course that provides participants with a better understanding of health priority setting and the application of cost-effectiveness analysis. This introductory course has no assumed knowledge. It represents a good foundation for other courses offered in the series.

<u>Practical Methods for Health Economic Evaluation (11th-13th October, In-person)</u>

A three-day intensive computer-based course in methods for health economic evaluation. The course covers study design principles, techniques for analysing costs and outcomes and an introduction to decision models.
